



## Terms and Conditions

By ordering wine from this email list you agree to our terms for payment and shipping. We operate at the whim of governmental authorities and as such, our shipping conditions may change at any time.

### Payment

When you first order from us, we will ask for a shipping address, a billing address and a credit card (we accept VISA and Mastercard).

We will charge you for each order when placed. We will charge for shipping when we ship wines. Shipping costs are at our cost which include packaging and shipping.

### Shipping

1. We require that you be 21 years of age to order wine.
2. A valid ID is required (and may be asked for) for wine to be received from us. An adult must be present when the wine arrives. We will not leave wine at a location without an adult signature. There are no exceptions.
3. We will not ship to PO boxes.
4. We do ship to business addresses.
5. The law does not allow us to ship to the following states.

This list is subject to change at any time due to the vagaries of interstate wine shipping laws. In the event of a change, we will notify you and ship to another location or refund your money and drink the wine ourselves. The following states have restrictions as listed:

Alabama - Will ship to a local State Run Store for pick up by consumer

Alaska - 2nd day Air service only

Arkansas - NO CONSUMER SHIPMENTS

Hawaii - 2nd day Air service only

Kentucky - NO CONSUMER SHIPMENTS

Massachusetts - NO CONSUMER SHIPMENTS

Mississippi - NO CONSUMER SHIPMENTS

New Hampshire - SHIPPING PERMIT MUST BE ON FILE WITH US

North Dakota - NO CONSUMER SHIPMENTS

Pennsylvania - NO CONSUMER SHIPMENTS

South Dakota - NO CONSUMER SHIPMENTS

Utah - NO CONSUMER SHIPMENTS

For those of you who live in a state on the do not ship list, we suggest you ship to a friend in a friendly state. Also, write your legislator and encourage him to press for a revocation of the archaic law that limits your freedom to buy what you want.

6. Wine is shipped from our temperature controlled warehouse in Central California.
7. We ship in the spring and the fall because temperatures are optimal then.
8. We will reach out to you during shipping season to alert you to the fact that your wine is coming.
9. We will wait to ship until you have a full case or until we have been holding your first wine for a year.
10. Please be aware of the shipping laws in your state regarding shipping and receiving wine. It is your sole responsibility to comply with local regulations regarding shipping. Title on all wine passes to the buyer (you) at the time of purchase in the state of California. We make no claims as to your legal right to receive wine in your state. If you require that your wine be shipped, you authorize Fass Selections, Inc. to engage a common carrier (e.g. Federal Express) to deliver the wine on your behalf.
11. You may cancel an order anytime before you have been billed without penalty.
12. If you believe the wine to be flawed please e-mail or call us as soon as possible and we will discuss the matter with you. We do not guarantee older bottles of wine (over 5 years).
